Telecom tower safety standards are the most important guidelines in the telecommunications industry. They are designed to ensure the structural integrity of towers and the safety of all personnel. In addition, the Act's General Duty Clause, Section 5(a) (1), requires employers to provide their employees with a workplace free.
